

DATA PROTECTION STATEMENT AND DATA MANAGEMENT RULES

The Móksha Gyógyír Ltd. is doing its best to protect your personal data, taking into account the dispositions of the Hungarian Civil Code Law LXIII of 1992, which states that personal data should be protected while data of public interest may remain unprotected.

The Móksha Gyógyír Ltd. guarantees that the personal data of team members, buyers or consumers provided on registration or ordering will be handled according to the laws in force that at the time ensure data protection. These data will be kept safe, used with discretion and will not be passed to third persons.

Data provided on registration – which qualifies as the team member's registration- can be accessed, besides Móksha Gyógyír Ltd., by the directors of the group into which the team member has registered, but they cannot pass them to third parties. The directors of teams, sponsors can use these data only for own purpose, for contacting team members about Móksha drop activities and to provide information about selling the product. If the director, sponsor give out or use these personal data for sending spams, or anyhow mishandle the data he/she knows, which breaks the member or the Móksha Gyógyír Ltd. rights, obligated to pay indemnity.

The registered person acknowledges that the Móksha Gyógyír Ltd. will be using the received data in sales and in thus circles who's charged for sales

If a registered team member data are used by the directors of his/her group otherwise than required for the activities of Móksha Gyógyír Ltd., this gives grounds for the cessation of the contract. Every registered natural or artificial person who hands over data or makes them accessible to or for third parties as a result of his/her being or having been employed by legal contract with Móksha Gyógyír Ltd. can be held responsible and obliged to pay indemnity.

During registration and ordering the data which contains the delivery information can be and will be handled to any courier company which is in contract with Móksha Gyógyír Ltd.

After the registration the Móksha Gyógyír Ltd. will save the datas till the contract is alive with the registered – natural- or artificial – person. After the contract is terminated the datas will be erased.

A registered natural or artificial person can request in writing (letter with notice of receipt) that his/her data be deleted from the company's records. In this case the deletion of data also means the end of the contractual bond. Móksha Gyógyír Ltd. is required to immediately fulfil such request.

The Móksha Gyógyír Ltd. has no means of checking the truthfulness of personal data or to be sure that they have been provided by someone really wanted to register, shop or consume. Móksha Gyógyír Ltd. cannot be held respnsible for these or similar abuses or whatever direct or indirect damages result from them.

If you witness any kind of data abuse please report it immadiately to Móksha Gyógyír Ltd.

Once we have received the notice of abuse, we will check the data in question and investigate its origins. False data or data provided by someone else without the owner's consent will be deleted from the system at once.
